

General Terms and Conditions

General Terms and Conditions of Donation for Basket Slovanka, z.s. is governed by the law of the Czech Republic, while the decisive day for the validity and effectiveness of legal norms is always the day when the payment is credited to the account of Basket Slovanka, z.s.

GENERAL CONTRACTUAL CONDITIONS of the sports club Basket Slovanka, z.s.

I. Preamble

These General Terms and Conditions (hereinafter referred to as the "GTC") apply to the sending of financial donations on the website www.eurobasket.cz (hereinafter referred to as the "Website"). The purpose of these GTC is to define and specify the rights and obligations of the registered association Basket Slovanka, z.s. (hereinafter referred to as BS) on the one hand and the donor on the other hand in providing financial gifts to BS through the Website.

II. Web operator

The operator of the website www.eurobasket.cz and at the same time the owner of the account is:

III. EUROBASKET donor project

Eurobasket is a long-term sports project organized by BS.

The main goal of the donations is to enable direct and effective support of sports, educational, health and social education of children and youth up to 18 years of age during the long-term activities of the club.

Furthermore, when organizing sports competitions, tournaments, matches, camps and camps for both BS members and non-BS members.

IV. Support

On the website www.eurobasket.cz, donors can contribute to the BS account using the PayU payment gateway.

V. Definition of some terms

Donor on the portal means a natural or legal person who, through the payment portal PayU, to which she was automatically redirected from the Website after using the "Pay" button, made the payment financial donation to the BS account.
(hereinafter referred to as the "Donor").

Electronic donation form means a submitted electronic form containing information about the Donor, processed by the Web system (hereinafter referred to as the "Form").

Financial gift means any amount entered by the donor, which was the Donor through the payment portal PayU, for which he was automatically from the Website redirected after filling in the Form and pressing the "Pay" button, paid to the account BS (hereinafter referred to as "Gift").

VI. Form, Gift

The Donor acknowledges that the Form filled in by him will be delivered to the BS. BS undertakes to accept the Form from the Donor filled in via the Website.

The Donor acknowledges that after entering the payment details on the PayU payment portal website, to which he will be redirected from the Website after pressing the "Pay" button, the selected amount will be deducted from his bank account once.

In the event that the Donor indicates when filling in the Form that he wants to send a confirmation of the Gift, BS undertakes to issue the Donor and send the relevant confirmation to the email address specified in the Form no later than 14 days after crediting the Gift to the BS account.

The Donor understands that, if necessary, all other information regarding his Gift will be sent to the email address provided in the Form.

VII. Protection of personal data

BS collects the personal data of the Donor through the submitted Form on the Website exclusively to fulfill its obligations to the Donor, especially when issuing a confirmation of the Gift.

BS is responsible for ensuring that the Donor's personal data will not be used for other purposes, in particular will not be disclosed to third parties

- if the donor is a natural person: name, surname, residential address and e-mail address;
- if the donor is a legal entity or self-employed person: business name, ID number, billing address and e-mail address.

The donor declares that he agrees in the sense of Act No. 101/2000 Coll., On the protection of personal data, as amended, that BS processes and stores his personal data, especially those listed above and / or which are necessary for the activity BS and processed them.

The donor grants this consent for an indefinite period.

The Donor may revoke the consent to the processing of personal data at any time in writing.

The consent will expire within 1 month from the delivery of the BS appeal and the data will be subsequently deleted.

VIII. Public Terms and Conditions - (hereinafter referred to as GTC)

These GTC regulate the mutual rights and obligations between BS and Donors.

VSPs are freely accessible to Donors, as well as to other visitors to the Website, at the Internet address (URL): <http://www.eurobasket.cz>, where they can get acquainted

with them. The donor can print or save the VSP via the appropriate functions of a web browser.

By sending the completed Form, the Donor declares that he has read the GTC and agrees with them.

BS is entitled to unilaterally change the GTC to a reasonable extent at any time, especially due to changes in legislation or technological changes. The change of the GTC is effective on the day of their availability on the Website, unless the BS sets a later effective date. The new GTC with the incorporated changes will be published in the form of the full text of the GTC on the Web.

IX. Final Provisions

The relations established between BS and the Donor when providing the Gift via the Website are governed by Czech law.

This version of the VSP is valid and effective from February 17, 2021

In the event that any provision of the GTC is invalid or ineffective for any reason, this fact does not cause the invalidity or ineffectiveness of other parts of the GTC.
